Bruce Bird, Alameda County Volunteer Organizations Active in Disaster (AlCo VOAD)

- AlCo VOAD is a non-governmental group made up of many different types of organizations are part of this group: non-profits, for profits, government agencies, faith-based groups, etc.
 - Does not respond to disasters per se, but links resources together for emergency preparedness and situations, i.e. emergency management
 - Shelter, financial support, food distribution, mental health, language translation, donations, etc.
 - Meetings occur quarterly all over the county. The next meeting is July 27th at American Red Cross in Oakland on Broadway.

RCEB Staff—Beth Dewitt

- HCBS RFP monies have been distributed
 - Waiting on more information from the Department, but agencies have been contacted
- ABx2-1 Funding for new vendors
 - Three regional centers have heard that some programs that received their vendorizations July 1st, 2016 or later are now eligible for ABx2-1 wages and benefits funding, but RCEB has not been contacted.
 - Seems to be only CPP providers with local negotiated rates that are affected. The State already adjusted the non-negotiated provider rates.
- RCEB is committing to updating the Community Services webpage more regularly.

- Rose Dawd, RCEB's Employment Specialist, is making her way to providers. Currently working on organizing data, teams, and case managers.
- No word yet from the Department on vendor reporting of ABx2-1 funds due October 1st, 2017.
 - o RCEB recognizes that it will be a challenge to reach smaller and monolingual vendor organizations
