State news

- Governor released budget on 1/10. Budget was as expected. No significant cuts and all initiatives related to ABX21 remain.
- No significant increases. 1.9 billion insufficiency reported, which is not entirely accurate. Governor is concerned about the new Administration-there are many questions about the cuts to the ACA, Medicaid, sanctuary cities which will pose many risks to the state and its people.
- Most actions will be seen at the time of the May revise. Prepare for hearings to start in March and be present to advocate for no cuts or reduction in funding.
- Administration has proposed to end the Coordinated Care Initiative. It is determined this will cost more and there are many implications to counties where it is already in place.

RCEB

- Minimum wage increase: RCEB has received information about the process needed for increasing the rate from \$10 to \$10.50. For rates that are set by the state, this will begin once service for December has been paid. Staff will then process increases and have them in place in time for January billing. Rates set by DDS-they will be in touch with providers outlining what needs to be done by March 1st in order to receive the increase. Rates set by RCEB: letters are being sent to providers outlining information that will be needed.
- Executive Director position: Jim is retiring soon and the Board is putting together a process for recruitment. Job description has been updated and posted today. A search committee in place and they are seeking input from community members, PVAC about qualities desired in a new ED. Interim ED will be Santi Rogers. Jim will be working through June with a goal of hiring a new ED by July. If the process takes longer, Santi and Jim have committed to continue assisting.
